### **DECLARATION OF CANDIDACY/FORM EL-162sd**

This is NOT an amendment unless you previously submitted candidacy papers for the 2024 election and need to make a correction.

### **CAMPAIGN REGISTRATION STATEMENT/FORM CF-1**

#### **SECTION A: GENERAL INFORMATION – Candidates must complete.**

Box A1: You may simply write your name in this box.

Box A2: Candidate

Box A3: Provide a private email address – not your school board email if incumbent.

Boxes A4: Provide your best contact phone number.

A5-A8: Provide your home mailing address.

Boxes A9-A13: This will be your bank as the Depository unless you have opened a separate account for campaign funds.

Boxes A14-A20: This will be your name as the Treasurer unless you have someone else acting as your treasurer.

Boxes A21-A28: Complete if applicable.

Box A29: You are eligible for exemption unless you plan to accept contributions or make disbursements greater than \$2,500 in total.

#### **SECTION B: CANDIDATE COMMITTEES – Candidates must complete.**

Box B1: Enter 'School Board member for Deerfield Community School District'

Box B2: Optional

Box B3: Enter 'April 2, 2024'

Boxes B4-B10: Provide your information.

Box B11: Most likely you will answer 'yes', unless you hold another state or local elective office.

Box B12: Complete if applicable.

**SECTION C: RECALL COMMITTEES** – most likely does not apply

**SECTION D: PAC, IEC, AND CONDUITS** – most likely does not apply

**SECTION E: POLITICAL PARTY & LEGISLATIVE CAMPAIGN COMMITTEES** – most likely does not apply
