# DEERFIELD TRIP CONDUCT AGREEMENT

## NEW ORLEANS TRIP – MARCH, 2018

I \_\_\_\_\_ (*student's name*) agree to abide by the following conduct agreement created by the directors of this trip. I fully understand that I will be responsible for my actions both in and out of the classroom. It is my responsibility to earn passing grades as well as behave in an appropriate manner. I understand that the teachers have the right to revoke my privilege of participating in the New Orleans trip at any time during the school year for failure to comply with this agreement. This includes, but is not limited to: disrespect to the teachers or other students, classroom violence, lack of participation, failing grades in any subject areas, truancy, tardiness, code violations, suspensions and multiple detentions. If I violate the co-curricular code for behavior reasons at *any* point during the school year, I will not be allowed to participate in this trip. I must also remain academically eligible (cannot have more than 1 D and 0 Fs) for the entire third quarter. (Grade checks will be done at the end of weeks 3 and 6. Students will be given 3 days to make up their grades; if students do not make up their grades in that time, they will lose their eligibility. After week 6, grade checks will be done weekly – any student academically ineligible after week 6 of 3<sup>rd</sup> Quarter will lose their eligibility automatically). After December 15<sup>th</sup>, 2017, I am responsible for the complete cost of the trip (even if I become ineligible to go and/or decide not to participate). I understand that I will be representing Deerfield High School during the entire trip and will be expected to act in an appropriate manner at all times. I also fully understand that if I violate this conduct agreement at any time during the trip that I will be sent home immediately at my own expense.
